Dear Signatory Employer:

This will advise that pursuant to the 2023-2027 Collective Bargaining Agreement between Laborers Union, Local #872 and NAMC, NCA, WWCCA and PDCA; the **July 1, 2025 monetary increase of \$3.15 shall be allocated as follows:**

July 1, 2025	\$2.50 – Wage
	<u>\$0.65</u>- Health & Welfare
	\$3.15 Total

Enclosed please find Journeyman and Apprentice wage and benefit rate sheets **effective July 1, 2025 through June 30, 2026**. Wage increase/allocations shall be implemented and paid to employees within 45 days of receipt of written notification from the Union to the Employer and shall be paid retroactively to the effective date of such increase/allocation or within the first full week of the Employers pay period. A penalty of one (1) day straight time rate of pay shall be paid to employees for each day of waiting time beyond the 45 days, until such wage increase/allocation payments are made.

The remittance form you receive monthly will reflect increases effective July 1, 2025 forward. Vacation, supplemental dues and DC Pension contributions shall be remitted pursuant to applicable overtime premiums and will be reflected on the remittance form.
